**Two new management positions created**

The Board of Directors has created two new positions in order to help the park to run more smoothly.

The first is called the **Maintenance/Project Manager**. This employee is responsible for overseeing the Park's maintenance department and all construction, remodeling, and landscaping type projects. Many applicants were considered for this very important position. The General Manager and the newly formed Personnel Committee finally decided to offer the position to a candidate named **Mark Vincent**. We are looking forward to a great year with him at the helm of our projects and maintenance crew.

The second new position is **Controller**. This employee is the chief financial officer for the park. As with the new Maintenance/Project Manager position, many highly qualified people were interviewed for this pivotal job. **Thomas Engle** was finally selected, and will start work within a few weeks. His arrival is highly anticipated.

**New Activities Director**

Our new Activities Director is **Lenny Ammerman**. He is coming to us from the activities program at Lost Valley Lake Resort in Owensville, MO. The Board has approved the funds for fifteen concrete site pads to be poured on existing sites in Phase 1. Six pads have been poured so far.

We have received the permits for the B site upgrade in Phase 1. That project should be able to move forward within a few weeks.

## Work Camper Program changes

The Board has approved some changes for the Work Camper Program that will have a big impact.

The hourly requirement for member work campers has been reduced from 32 hours per week per site to 20 hours. Non-member work campers will have to put in 24 hours per week per site. There is no longer any time difference between couples and singles.

Work campers and paid employees are now the only people that will be allowed to stay more than 21 days out of any 30 day period due to our return to the original restrictions.

Fishing at the Phase 2 pond is now limited to children ages twelve and under. An adult must accompany the child for safety reasons. This pond will be stocked with only small bluegill type fish. The Welcome Center pond will be stocked with catfish. Fishing gear will be available for purchase at the Treasure Lake store.
