**BOARD OF DIRECTORS ADOPTS A PROCEDURE
FOR FILLING VACANCIES PRIOR TO THE END
OF ELECTED TERM**

Pursuant to Article V, Section 4, of the By-Laws of Treasure Lake R.V. Resort Camping Club, Inc., which reads:

1. Vacancies. Any vacancy occurring in the Board of Directors shall be filled by the affirmative vote of a majority of the remaining Directors within 30 days. A Director appointed to fill a vacancy shall hold office for the balance of the term of the Director replaced. Any directorship to be filled by reason of an increase in the number of Directors shall be filled at an annual meeting of the members or a special meeting of the members called for that purpose.

When a vacancy on the Board of Directors occurs, the candidate with the next highest number of votes from the previous election will be considered first for filling the vacancy. If the vacancy is not filled either by a lack of a majority affirmative vote of the remaining Directors, or the candidate declines acceptance of the office, then the Board will consider any qualified members who have a petition signed with 25 members in good standing and a resume on file with the Board.

The Board shall post on the Treasure Lake Resort website that applications and resumes will be accepted from qualified members to be considered in the event there is a Board vacancy. Applications shall expire after 6 months and will have to be resubmitted to remain eligible for review.
