The claim arose on or about FEBRUARY 18, 2009 as a result of the following events:  
RESPONDENT BOARD FAILED TO RECOGNIZE & PAY DUAL MEMBERSHIP BENEFITS SPELLED OUT IN COURT CASE 07AF-CV00582.

- A) LOSS DUE TO BOARD NOT RECOGNIZING 365 DAY/YEAR USE \$1500.00
- B) EXCESS TRAVEL WITH HAVING TO LEAVE PARK EARLY \$ 437.30
- C) REFUND OF 2 YEARS MAINT FEE PAID ON DEED WE WERE NOT ALLOWED TO USE \$ 999
- D) REFUND OF FUNDS CONTRIBUTED TO CASE 07AF-CV00582 \$ 200.00
- E) COST TO BRING THIS SMALL CLAIM ACTION TO FORCE TREASURE LAKE BOARD TO PAY ITS JUST INDEBTEDNESS \$ 50.00
